## **PLEASE NOTE**

- 1. Where the number of applicants exceeds the number of places available, Young Eagles Christian Academy may at the discretion of its Administrators and Principals give special preference to siblings of a learner currently enrolled at the school.
- 2. Young Eagles Christian Academy may also give preference to:
  - · Learners transferring from another Private School using the ACE Curriculum Program.
  - · Learners transferring from a Home School using the ACE Curriculum Program.
- 3. If there are any circumstances (including medical conditions or disability) that require special consideration by Young Eagles Christian Academy, please inform us by separate letter attached to this application.

## CONTRACTUAL DECLARATION

I / We being the parent / guardian of the applicant hereby:

- 1. Apply for a place at Young Eagles Christian Academy for the applicant to become a learner and to be enrolled at the admission date requested.
- 2. Enclose:
  - A payment to the amount of R2 000.00 Registration Fee plus a non-refundable Application Fee of R150.00. The R2 000.00 Registration Fee is refundable if the application is withdrawn prior to a formal placing.
  - A clear copy of the parents' identity document.
  - A clear copy of the immunization card or waiver.
  - A clear copy of the applicant's latest Progress Report (where applicable).
  - A clear copy of the applicant's birth certificate.

The application will only be considered for processing once all the above has been received. On the first day of school at Young Eagles Christian Academy a Letter of Transfer from the previous school is also required.
